### **About the Volcker Alliance**

The [Volcker Alliance](#) is a nonprofit founded by former Federal Reserve Board Chairman Paul A. Volcker to empower the public sector workforce to solve the challenges facing our nation. Our portfolio of work focuses on the people at the core of government service delivery—people who provide a steadfast source of optimism during an unsettled time for our democracy. We promote innovation in public service education, empower rising leaders to build the democracy of our future, connect talent to city, state, and federal government jobs, and inspire others with the story of Mr. Volcker’s commitment to public service.

The Volcker Alliance is committed to cultivating a diverse team and inclusive workplace. We believe that building a team whose members draw upon different lived experiences and offer myriad perspectives is critical to advancing our mission. To advance our mission, the Volcker Alliance needs employees who are as diverse as America, each bringing different insights into the work of government in communities across the country. We believe our success hinges on engaging employees who are Black, Indigenous, and people of color. We strongly encourage applications from people with these identities or who are members of other historically excluded and marginalized communities.

### **About the Program**

The Public Service Ambassador Initiative is a national program that engages AmeriCorps alumni to listen to rising leaders, build community and connection, and inspire civic purpose and service across the United States.

Communities nationwide are facing significant challenges amid declining trust and extreme polarization. Young people’s voices, perspectives, and leadership are essential to shaping the future of our country. The Public Service Ambassador Initiative empowers AmeriCorps alumni—action-oriented individuals with a unique blend of practical problem-solving skills and a deep commitment to the public good—to seek the perspectives of rising leaders, foster connections, and inspire them to serve, whether in their communities or through careers in local, state, or federal government. By creating space for listening, connection, and inspiration, the program strengthens civic connectivity.

### **Why AmeriCorps Alumni?**

The true promise of AmeriCorps lies not just in what members accomplish during their service year, but in what they can accomplish afterward. That’s why we are activating AmeriCorps alumni as Public Service Ambassadors. AmeriCorps Alumni bring a distinctive combination of hands-on experience and commitment to public service. Addressing local needs alongside community members fosters a lifelong lens through which alumni understand their country and appreciate their responsibility to strengthen it. AmeriCorps alumni know what it means to serve, to listen, and to lead from the ground up. Their service hones skills in facilitation, coalition-building, and policy implementation. Crucially, alumni have witnessed how engaged citizens create meaningful change—experiencing firsthand the pathways from individual concern to collective action.

## **The Role**

Public Service Ambassadors will collectively engage thousands of young people by learning what issues they care about, listening to their perspectives on the role of government in addressing those issues, amplifying their collective voices in shaping the future of our country, and inspiring and connecting them with meaningful ways to serve.

The Volcker Alliance is seeking AmeriCorps alumni from across the country to serve in this role. As an AmeriCorps alum, you bring lived experience in service, deep community ties, and the ability to navigate diverse stakeholders, making you uniquely well-positioned to lead this work.

## **What Public Service Ambassadors Will Do**

After completing training, Ambassadors will:

- **Host listening sessions** in their respective communities to understand the issues that matter most to rising leaders and explore their perspectives on the role of government in addressing those issues
- **Organize community events** that connect young people with current and former public servants, inspiring civic purpose and service
- **Inspire and facilitate pathways to service**, by guiding young people from interest to action, helping them identify volunteer roles, internships, fellowships, and career opportunities in public service that align with the challenges they care about
- **Serve as trusted connectors** between communities, service and youth-based organizations, universities, public servants, and public institutions

During 2026, Ambassadors will collectively engage thousands of young people nationwide, strengthening civic participation and deepening understanding of public service.

## **Ideal Candidate**

The ideal Public Service Ambassador is a community-centered leader who believes in the power of public service to create meaningful change and is motivated to inspire others to serve.

Strong candidates will bring the following qualities and experiences:

- AmeriCorps alumni status, with a demonstrated commitment to service and civic engagement
- Strong ties to their local community, including connections through volunteer organizations, professional networks, colleges and universities, or public institutions
- Experience engaging diverse groups, particularly young people, rising leaders, or community stakeholders
- Comfort facilitating conversations and creating inclusive, welcoming spaces for dialogue
- Creativity in co-creating effective and engaging events tailored to the resources and needs of their respective communities
- Organizational and self-management skills, including the ability to balance this part-time commitment alongside other responsibilities
- Interest in public service, whether through direct experience, advocacy, or community work
- Collaborative mindset, with enthusiasm for learning alongside peers, sharing best practices, and co-creating solutions
- Adaptability and initiative, with the ability to work independently while staying connected to a national cohort and support team

What matters most is a commitment to community, passion for public service, and a desire to help others imagine themselves as part of the public sector's future.

## **What You'll Gain**

As a Public Service Ambassador, you will:

- Make a meaningful impact in your community by listening to rising leaders and encouraging them to shape the future they want to see
- Strengthen local relationships with community members, public servants, and civic leaders
- Build a national peer network by forming deep relationships with fellow Ambassadors and reconnecting with AmeriCorps alumni across the country
- Develop advanced leadership skills, including community engagement, organizing, conflict management, and facilitating constructive dialogue

- Receive ongoing coaching and mentorship from the Volcker Alliance and partner organizations
- Continue your public service journey in new and influential ways, while helping to shape the future of the public sector

### **Time Commitment and Support**

- **Time commitment:** Approximately 20 hours per month, with flexibility to align with other responsibilities
- **Duration:** July-December, 2026
- **Compensation:** \$4,000 stipend plus a modest budget to enable community events
- **Orientation & Training:** Ambassadors must participate in an in-person structured orientation, facilitation training program and a co-design workshop July 14-17, 2026, before launching community-based activities; travel expenses and training will be provided free of charge to the Ambassadors
- **Ongoing support:** Ambassadors will participate in cohort-building activities, coaching, and mentoring throughout the program

**Application Closes:** Applications will be considered on a rolling basis, with priority given to applications submitted by May 4, 2026

**In-Person Program Orientation & Training in Boston (mandatory):** July 14-17, 2026 (travel and expenses will be covered)

**Duration of the Ambassador Work:** August-December, 2026
